Topics related to the following areas are of particular interest to neuroscience nurses: stroke, neurotrauma (brain, spinal cord), epilepsy, pediatric neurology, neuro-oncology, and neuromuscular movement disorders.

## Rules and Regulations

Corporate showcase sessions are assigned on a first-come, first-served basis pending AANN approval. The showcase fee is **\$15,000** and must accompany your completed corporate showcase application. Showcases are only available to those who purchase an exhibit booth. The fee includes space rental and listing on onsite signage that features all corporate showcase sessions. Corporate showcases will be listed in the AANN mobile app. Descriptive copy (limited to 50 words) must be sent to [mpaulson@aann.org](mailto:mpaulson@aann.org) with the application.

All activities are restricted to the designated area in the exhibit hall. You will be responsible for organizing your showcase. Your showcase area will be set up theater style for 200 attendees and will include an LCD projector/screen, podium, and microphone. You are responsible

for any special-need charges (e.g., catering, additional audiovisual equipment). Please note that, per meeting facility policy, no outside food or beverages are allowed at any meeting function.

Promotion or notification of your showcase is your responsibility. You may place a sign no larger than 28" by 44" in the registration area, at the entrance of the exhibit hall, and outside the designated area 24 hours before your showcase is scheduled to begin. You may promote your showcase through direct mail, bag insert, or program guide advertising for an additional fee.

Sessions are approved *after submission of the corporate showcase application form* on a first-come, first-served basis. All programs must be approved by AANN. No cancellations are accepted after space is confirmed. Payment is due upon submission.
