Dr. Meyer also served on the Clinical Practice Guideline (CPG) Editorial Board, was an author for the *Core Curriculum*, and President of ABNN. She is a Assistant Professor in Neurosurgery at the University of Louisville. President Meyer is joined by new and returning leaders dedicated to serving the AANN membership:
